- There will be three age groups: 10 years and younger, 11-17 years, and 18 years and older.
- The two older age groups will eat 1 pint of ice cream. The youngest age group will be served a smaller portion.
- Registration may be limited to 10 participants in each round per age group. First come, first eligible to enter. Cost is \$5 per person for children 10 years and younger & \$8 per person for all other ages.
- Prizes will be given only to 1<sup>st</sup> place in each round. There will be no prizes for 2<sup>nd</sup> or 3<sup>rd</sup> place.

**Rules**

- Contestants may eat using either spoon or hands.
- Contestants must wait for the starting signal to begin eating and may not touch any ice cream or utensils prior to the starting signal.
- The winners will be determined by who finishes their ice cream first.
- Contestants will be disqualified should you be unable to keep your ice cream down.
- Judges will be on hand to assure adherence to contest rules, monitor the no sickness rule, and to disqualify contestants who fail to adhere to the rules.
- In the event of a tie, whichever contestant displays the Wilson's Ice Cream smile will be declared the winner.
- Final Authority: Wilson's Ice Cream Parlor has final authority regarding all contest-related matters.
